## RESULTS OF A SUBSIDIARY

This announcement is made by the board (the “**Board**”) of directors (the “**Directors**”) of Global New Material International Holdings Limited (the “**Company**”) pursuant to the Inside Information Provisions (as defined under the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”)) under Part XIVA of the Securities and Futures Ordinance (Cap. 571 of the laws of Hong Kong) and Rule 13.09 and Rule 13.10 of the Listing Rules.

CQV Co., Ltd. (“**CQV**”), an indirect non-wholly owned subsidiary of the Company, is a company incorporated in the Republic of Korea, whose common Shares are listed on The Korea Securities Dealers Automated Quotations (“**KOSDAQ**”) (KOSDAQ: 101240). As at the date of this announcement, the Company holds 44.59% of the issued shares of CQV and is the single largest shareholder. CQV has announced its unaudited results for the six months ended 30 June 2025 on the website of The Korea Exchange. The results were prepared in accordance with Korean International Financial Reporting Standards.
